- 1] **Apologies for absence:** Coun. Vicki Plant

- 2] **Declarations of Interest** Coun. Carolyn Birch, item 7 and the application involving Kingston Brook Farm.

- 3] **Minutes from previous meeting on November 4, 2014** were accepted as circulated and signed by the chairman.

- 4] **Public participation, limited to 15 minutes**
Local residents Mr and Mrs Hibbitt of Kingston Brook Farm spoke on a planning application they had submitted to convert a barn at their premises into 2 dwellings. The clerk said the application had been submitted to the Borough under a new scheme introduced by the government aimed at making it easier to use farm buildings for conversion into dwellings. Mrs Hibbitt said they still waited the Borough Council making a final decision on their earlier application involving their present home on the same site.

- 5] **Clerk's report**
The Clerk attended the AGM of Notts NALC when Rushcliffe MP Kenneth Clarke spoke and urged all councils to try to ensure people were given every possible aid in putting their names forward for the elections for parish councils due on May 7 next year.
