Before the start of the meeting members signed their Declaration of Acceptance of Office forms.

- 1] **Appointment of chairman and vice chairman:**
Coun. David Roberts was elected chairman and Coun. Simon Stephens vice chairman.
- 2] **Apologies:** There were none
- 3] **Minutes from previous meeting** were accepted as circulated and signed by the chairman.
- 4] **Declarations of interest:** There were none
- 5] **Appointment of village hall representatives:**
Couns. Vicki Plant, David Grenz, Lindsay Redfern.
- 6] **Clerk's report including May 7 election:**
The clerk reported that there was one vacancy on the council because of under subscription of nominations.
- 7] **Casual vacancies:**
The council agreed to discuss the matter at the next meeting and attempt to make an appointment then. Members were asked to consider if they could suggest names for consideration. The clerk said if the council were able to fill the single vacancy at the next meeting they would not have to go through the normal procedure of allowing ten residents to call for an election.
